  - i. Bathroom Update

  - ii. Guest Policy Update
    - The Resort plan is still being reviewed by the Resort management. The Board agreed that non-members get no access to our software, our events and equipment, etc. Until we learn differently from Christine, our Club will hold to the current policy; members and organized play events take priority over non-members.
